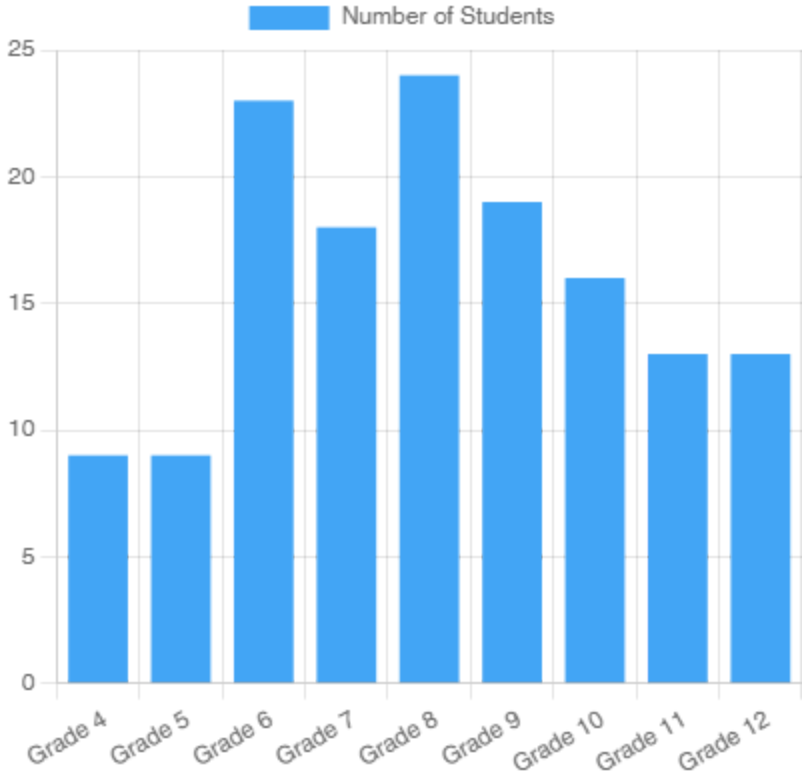

Sequoia Career Academy campus is comprised of three locations: the "main campus" includes an office with a library, staff room, and two administrative offices supporting three classrooms; eight classrooms are located on the Redwood Collegiate Academy campus (Amherst, Berkeley, Chico, Davis, Fullerton, Georgetown, Harvard, and Irvine); the Flower and Home Arts buildings on the Redwood Empire Fairgrounds. Students use the Junior building (also located on the Redwood Empire Fairgrounds) for lunch and extra-curricular activities. Our campus is small, allowing for tight supervision, which ensures a high degree of safety. Our facilities are clean and maintained continuously to ensure good repair. Our school grounds, buildings, and restrooms are cleaned five times a week and monitored throughout the day.

Sequoia Career Academy offers a Child Development pathway where students learn about children's physical, mental, emotional, and social growth and development and how to provide for their care and guidance. Students will also learn the foundations and theories of early childhood education and current issues facing early childhood education. All Juniors and Seniors participate in the program with high levels of success.

Sequoia Career Academy also offers a Business CTE pathway through Mendocino College where students learn the principles and techniques of delivering excellent customer service, individualized communication, problem-solving skill development, and working with people in an organizational setting. Students learn about perception, motivation, communication, leadership styles, group dynamics, decision-making, teamwork, and managing change.

Sequoia Career Academy students participate in career awareness courses. Beginning in 9th grade students enroll in their first career awareness course in which they are introduced to a variety of career pathways including (but not limited to): Arts, Media, & Entertainment; Education, Child Development, & Family Services; Hospitality, Tourism, & Recreation; Marketing, Sales, & Service; and the military.

Sequoia Career Academy 11th and 12th grades take My Career Pathway courses where they focus on: the skills necessary to be successful in a career, the benefits of volunteering, plagiarism, matching interests and occupations, realistic career goals based on lifestyle, personal values, options after high school, writing a resume, and etiquette. In addition to the two CTE pathways, career awareness courses, and My Career Pathway courses offered at Sequoia Career Academy, students in grades 10 through 12 may participate in college courses through Mendocino College if they are in good standing and on track to graduate.

Opportunities for Parental Involvement (School Year 2024–25)

The Sequoia Career Academy Board of Directors is comprised of current and former parents. Each month Sequoia Career Academy sends out a monthly newsletter updating students and families on upcoming events. These newsletters include links to our social media accounts that provide more information and allow students and families to contact us. Sequoia Career Academy also provides every student and their family access to PowerSchool which allows them to monitor grades and attendance. Three Parent Advisory meetings are offered per year in which parents are invited to meet with their school's principal. Showcase is offered twice per year which allows students and their families to meet their teachers and see what their students have been working on. There are two Family Fun Nights offered every year where families can come and participate in free, family-friendly activities with students, and our staff. In addition, parents and students have the opportunity to participate in the School Site Council. Parents are encouraged to chaperone field trips. Parents and families are notified of all of these opportunities to participate through our calendar of events, quarterly upcoming events notifications, and classroom communications.

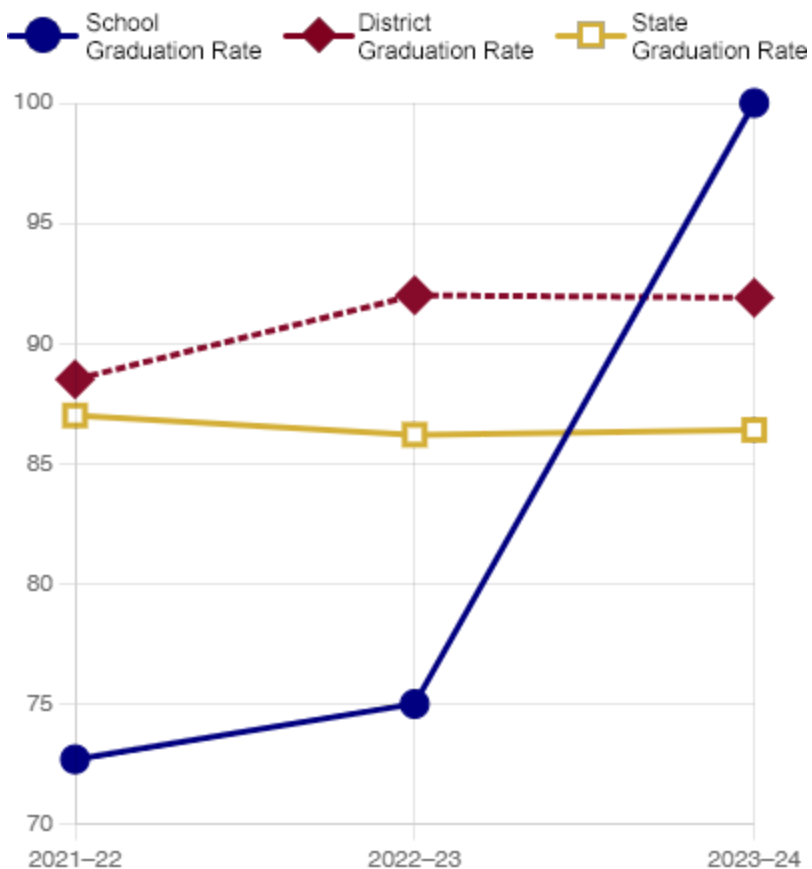

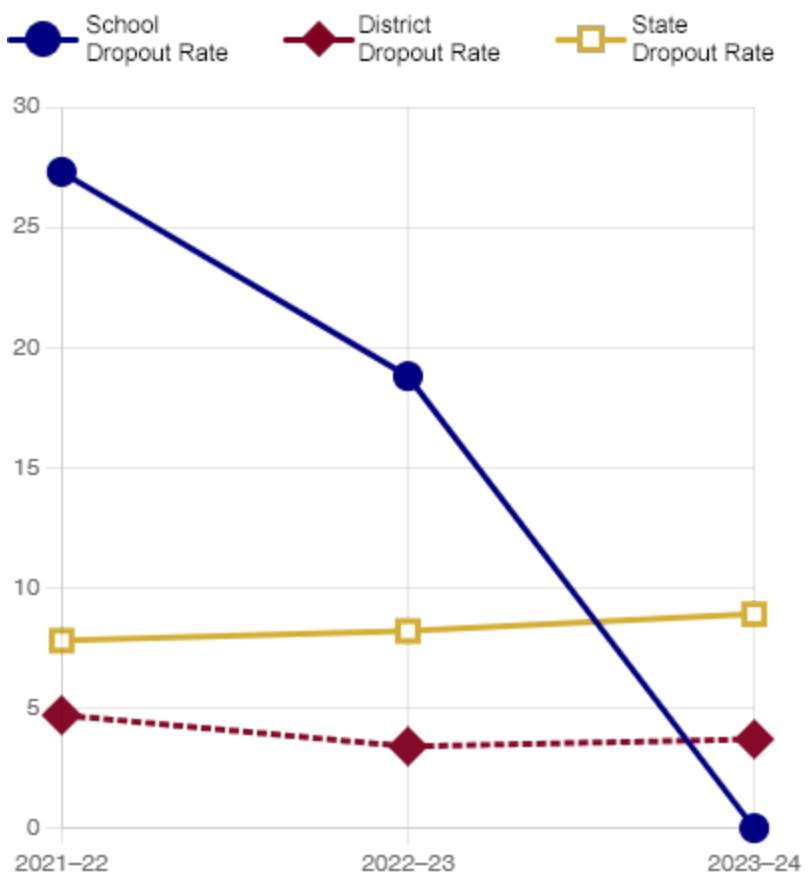

Types of Services Funded (Fiscal Year 2023–24)

Meals - All students at Sequoia Career Academy are offered free breakfast and lunch through the schools meal program. Lunches are prepared fresh daily through Willits Charter. In addition to breakfast and lunch the office and classrooms always had snacks for students.

Counseling - Sequoia Career Academy offered onsite counseling services 3 days per week with a licensed counselor and a counseling coach.

After-School Programs - An after-school program for grades 4-6 was offered after school Monday - Friday until 5:15 p.m. In the elementary after-school program students participated in preparing and sharing a snack, tutorial time, followed by time for fun activities. After-school tutorials were offered for grades 7-12 on the Sequoia main campus until 4:45 p.m. on Monday, Tuesday, Thursday, and Friday. In addition, to the after-school tutorials teaching staff also offered a teacher help hour once a week in their classrooms. Electives were offered by staff or community members to students in grades 7-12 after school Monday - Friday, electives included Art, Club Live, Yearbook, e-Sports, Robotics, and much more. Sequoia Career Academy also sponsored up to 3 students per semester to take one class at the School of Performing Arts and Cultural Education (SPACE) in Ukiah, CA.

Sports - Sequoia Career Academy offered Soccer in grades 9-12, Archery in grades 7-12, and Track and Field for grades 7-12.

Credit/Course Recovery - A credit/course recovery class is built-in to schedules for students in grades 11 and 12 who need to make up credits to ensure they graduate on time.

College and Career Planning - Sequoia Career Academy provided seniors and their parents a FAFSA night in collaboration with Mendocino College. During this event parents and students were walked through the necessary steps to complete the FAFSA. Our Academic Services Coordinator worked with students in small groups and one-on-one to apply for college at Mendocino College and register for classes. Juniors and seniors who were on track to graduate were able to take college classes through Mendocino College at no cost to

them. In addition, 2 business courses were taught on-campus throughout the year, BUS-107 Customer Service and BUS-134 Human Relations in Business. Students in grade 10 participated in a career exploration course in which they explored various careers in different fields ranging from culinary, woodworking, gardening, the military and much more. Students in the Career Exploration course built flower boxes for the campus and filled them with plants. Students in grades 11 and 12 were enrolled in My Career Pathways courses that took place Monday - Friday and focused on resume writing, filling out job applications, career exploration, communication and conflict resolution skills, as well as any student driven topics to prepare students for their future.

Field Trips - Students in all grades took a number of different field trips including, but not limited to: cultural shows, exhibits, and events, The Academy of Science, various museums, local career option pathways including MetalFX and Precision Sheet Metal, tours of Mendocino College.

ELD Program - English-learners were identified at the beginning of the year based on the previous year ELPAC scores and then students were pulled out 3 times per week in small groups where they utilized Read Naturally, Rosetta Stone, and various supplemental resources. In addition, to ELD support students were also provided with additional support on assignments as needed.

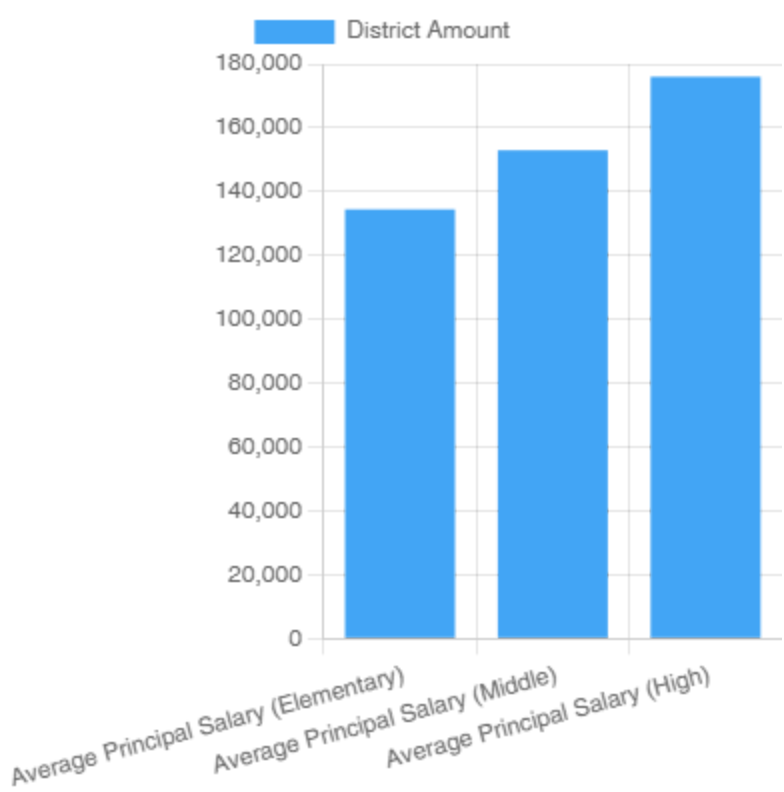
